## **Description**

Reconstruction Capital II ("RC2" or the "Fund") is a closed-ended, absolute return driven investment fund, incorporated in the Cayman Islands. The fund invests in Private Equity & Listed Securities in South-East Europe. RC2 was admitted to the AIM market of the London Stock Exchange in December 2005 raising  $\epsilon$ 24m initially, with two follow-on offerings in May-06 and Dec-07 raising a further  $\epsilon$ 40m and  $\epsilon$ 71m net of expenses respectively. New Europe Capital SRL (Bucharest) is the adviser to RC2.


